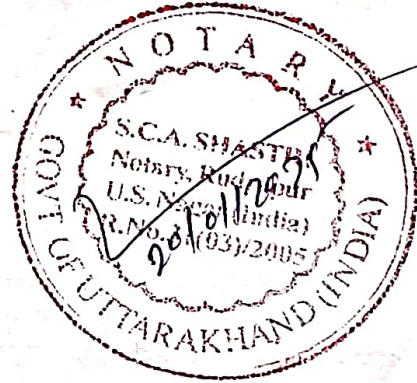
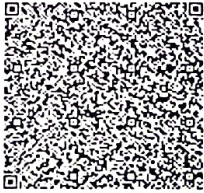

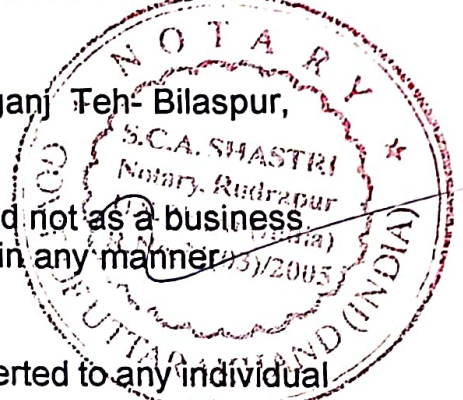
**AAFIDAVIT**

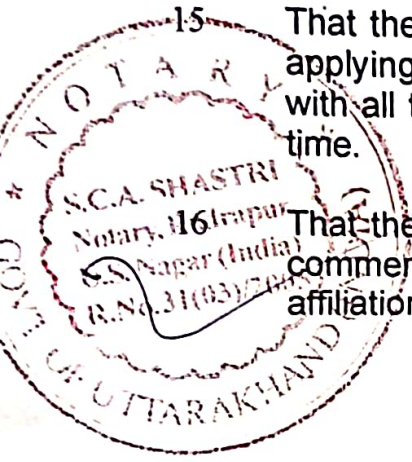
